RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MT. CARMEL, WABASH COUNTY, ILLINOIS

WHEREAS, the City of Mt. Carmel, Wabash County, State of Illinois is in need of funding in order to meet obligations related to the purchase of a street sweeper; and

whereas, City desires to borrow \$ 169,655 for a term of ______ for a term of ______ years; and

WHEREAS, City has obtained financing proposals from an area financial institution for the loan; and

WHEREAS, City intends to repay the loan from all existing revenue sources along with the additional revenues obtained from the Motor Fuel Tax payments; and

WHEREAS, after obtaining competitive bids for financing, the City desires to accept the lowest financing offer and, therefore, desires to obtain a loan from The First National Bank, a National Banking Association, with banking offices in Allendale and Mt. Carmel, Illinois (Bank), for the purpose of providing the needed financing; and

WHEREAS, said loan will be made for a term of $\frac{6}{3}$ years at a fixed interest rate of $\frac{3}{3}$ % per annum; and

WHEREAS, said loan will be for the principal sum of $\frac{169}{69}$, $\frac{169}{69}$, and will not bear any penalty for prepayment.

NOW, THEREFORE, BE IT RESOLVED, that a loan in the amount of 169,655. be obtained from Bank at a rate and upon the terms as recited, herein; and that the Mayor and the City Clerk of the City of Mt. Carmel are hereby authorized, on behalf of the City, to execute all loan documents necessary to achieve the purposes of this Resolution.
