COMMISSIONER MIKE WITTERS – STREETS, CEMETERIES AND PARKS

Commissioner Mike Witters had no report.

<u>COMMISSIONER NORMAN BRUNSON – FIRE, HEALTH & SAFETY, GARBAGE, CITY HALL</u> <u>AND CIVIL DEFENSE</u>

Commissioner Brunson reported that the Fire Department responded to 6 runs in the past 2 weeks.

COMMISSIONER BILL HUDSON – WATER AND SEWER

Commissioner Hudson stated that January 26 was Rob Windes last day as superintendent of the water and sewer departments, but he has agreed to serve in a consultant role for his replacement at the city sewer department until Josh Peach obtains the Class 1 Operator state license. Commissioner Hudson announced the appointment of Josh Peach to the top post in the sewer department but explained the process for completing the Class I Operator often takes two to three years. Commissioner Hudson said water department employees, Mary Duckett and Bill Miller will guide water department operation responsibilities previously handled by Mr. Windes.

Two sewer lift stations were repaired in the Ficklin and Pecan streets areas and another one replaced on outer 9th Street. A pump was replaced at the Skiles Building, also.

Commissioner Hudson stated that the water department crews installed 60 feet of main on the Columbus Drive area, also doing work at two locations on Lambert Drive and one location on Westwood Drive.

Commissioner Hudson stated that the water department will begin a random replacement of water meters, beginning February 8. This work is being done in conjunction with the Energy Systems Group (ESG) study regarding water meter accuracy.

Administrative Assistant Rudy Witsman

Administrative Assistant Rudy Witsman announced the scheduled March 21 meeting of the city council will be moved to March 22 to accommodate a candidates forum planned at Wabash Valley College on March 21. The city election will be on April 5, when a mayor and four commissioners will be elected to 4-year terms of office.

Administrative Assistant Rudy Witsman said the city hopes to save taxpayers over \$100,000 of an estimated cost the municipality could experience while achieving satisfactory flood levee inspections. The work is ongoing, including updating of operations manuals, culvert inspections, elevations reports and other details needed by the Federal Emergency Management Agency to certify the levee system. The levees are an insurance benefit, especially for properties in the flood plain areas.
