Effective August 26, 2019 to December 19, 2022

A-1 City Domestic Residence: Nineteen Dollars (\$19.00)

Effective December 20, 2022 to July 19, 2023

A-1 City Domestic Residence: Nineteen Dollars and Seventy-five cents (\$19.75)

Effective July 20, 2023

A-1 City Domestic Residence: Twenty Dollars and twenty-five cents (\$20.25)

All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

Except as herein set out, Sec. 10-1/2-15 shall remain unchanged.

This ordinance shall be in full force and effect upon its passage and approval by the Mt. Carmel City Council, as provided by law.

This ordinance shall be printed in pamphlet form.
