

ORDINANCE NO. 2076

AN ORDINANCE AMENDING CHAPTER 21, WATER AND SEWER, ARTICLE IV. SECTION 21-86. **BASIC USER RATES**

WHEREAS, the City Council of the City of Mount Carmel, Wabash County, Illinois, has determined that it is necessary to establish water and sewer rates for commercial and residential users.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MT. CARMEL, ILLINOIS, Chapter 21, WATER AND SEWERS, Article IV, Section 21-86 (d) Basic User Rate; is hereby amended to state:

(17) Effective after September 20, 2022, thru September 19, 2023.

Basic user rate: There shall be, and there is hereby, established a minimum charge and a basic user rate for the use of and for service supplied by the wastewater facilities of the city.

A minimum charge of \$16.20 per month shall be applied to all users.

A basic user rate of \$3.29 per 1,000 gallons shall be applied to all commercial users for water consumption in excess of 1,000 gallons per month. A basic user rate of \$3.79 per 1,000 gallons shall be applied to all residential users for water consumption in excess of 1,000 gallons per month.

All non-metered residential users of the wastewater facilities shall pay a minimum flat rate charge per month adequate to cover the costs of the minimum debt service charge, the minimum service charge and the basic user rate of \$24.25 plus \$4.25 = \$28.50.

(18) Effective after September 20, 2023, thru September 19, 2024.

Basic user rate: There shall be, and there is hereby, established a minimum charge and a basic user rate for the use of and for service supplied by the wastewater facilities of the city.

A minimum charge of \$16.20 per month shall be applied to all users.

A basic user rate of \$3.79 per 1,000 gallons shall be applied to all commercial users for water consumption in excess of 1,000 gallons per month. A basic user rate of \$4.29 per 1,000 gallons shall be applied to all residential users for water consumption in excess of 1,000 gallons per month.

All non-metered residential users of the wastewater facilities shall pay a minimum flat rate charge per month adequate to cover the costs of the minimum debt service charge, the minimum service charge and the basic user rate of \$28.50 plus \$.50 = \$29.00.

19) Effective after September 20, 2024.

Basic user rate: There shall be, and there is hereby, established a minimum charge and a basic user rate for the use of and for service supplied by the wastewater facilities of the city.

A minimum charge of \$16.20 per month shall be applied to all users.

A basic user rate of \$4.29 per 1,000 gallons shall be applied to all commercial users for water consumption in excess of 1,000 gallons per month. A basic user rate of \$4.79 per 1,000 gallons shall be applied to all residential users for water consumption in excess of 1,000 gallons per month.

All non-metered residential users of the wastewater facilities shall pay a minimum flat rate charge per month adequate to cover the costs of the minimum debt service charge, the minimum service charge and the basic user rate of \$29.00 plus \$.50 = \$29.50.

Except as herein amended, all other provisions of said Chapter 21 shall remain unchanged, except as to that part thereof in conflict with this Ordinance or which is repealed by this Ordinance.

This Ordinance shall be in full force and effect upon its passage and approval as provided by law.
