ORDINANCE NO. 2075

AN ORDINANCE IN RELATION TO MOTOR VEHICLE PARKING

WHEREAS, the City Council of the City of Mt. Carmel, Wabash County, Illinois, in order to promote health, safety and free flow of traffic, has determined that there should not be parking on City streets in certain designated areas in the City of Mt. Carmel, Illinois.

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MT. CARMEL, WABASH COUNTY, ILLINOIS, that Chapter 15, Section 15-104(a), Parking Prohibited in Specified Areas, is hereby altered and amended to include the following, to-wit:

Section 15-104(a). Parking prohibited in specified areas.

Parking of all vehicles shall be prohibited and it shall be unlawful to permit any vehicle to stand or park along and upon either side of the Northern Cul-de-sac on Southgate Drive within the corporate limits of the City of Mt. Carmel, Wabash County, Illinois.

Parking of all vehicles shall be prohibited and it shall be unlawful to permit any vehicle to stand or park along and upon either side of 13th street from Market Street to Chestnut Street within the corporate limits of the City of Mt. Carmel, Wabash County, Illinois.

Any person who violates any provision of this Ordinance is guilty of a misdemeanor and upon conviction thereof shall be punished by a fine of not less than \$25.00 nor more than \$500.00 for each offense as provided in Section 15-2.

Except as herein amended, all other terms and conditions in Chapter 15 of the City Ordinances shall remain unchanged.

All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

This ordinance shall be in full force and effect upon its passage and approval by the Mt. Carmel City Council, as provided by law.

This ordinance shall be printed in pamphlet form.




