

ORDINANCE NO. 2070

AN ORDINANCE APPROVING THE SUBDIVISION OF A TRACT OF LAND OWNED BY DONALD E ADAMS IN THE CITY OF MT. CARMEL, WABASH COUNTY, ILLINOIS

Whereas, Donald E Adams is the owner of a certain tract of land more particularly described as follows:
