ORDINANCE NO. 2064

AN ORDINANCE RESCINDING ORDINANCE 2063 FEE LICENSE.

WHEREAS, the City Council of the City of Mt. Carmel, Wabash County, Illinois feels a \$250.00 fee per video gaming terminal would be an undue financial burden upon local businesses; and

WHEREAS, Ordinance 2063 authorized a fee of \$250.00 per video gaming terminal per year; and

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MT. CARMEL, WABASH COUNTY, ILLINOIS, Ordinance 2063, is hereby rescinded:


All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

This ordinance shall be in full force and effect upon its passage and approval by the Mt. Carmel City Council, as provided by law.


This ordinance shall be printed in pamphlet form.




