ORDINANCE NO. 2063

AN ORDINANCE AMENDING CHAPTER 14, LICENSES AND BUSINESS REGULATIONS
ARTICLE III, COIN OPERATED AMUSEMENT DEVICES

Section 14-38. Fee License.

WHEREAS, the State of Illinois has adopted the Video Gaming Act which provides for the placement and regulation of Video Gaming Terminals, and;

WHEREAS, 230 ILCS 40/65 provides that a non-home rule unit of government may not impose any fee for the operation of a Video Gaming Terminal in excess of Two Hundred Fifty Dollars (\$250.00) per year.

That it is necessary for the City of Mt. Carmel, Wabash County, Illinois, in order to be in compliance with said law, to amend its ordinances.

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MT. CARMEL, WABASH COUNTY, ILLINOIS, Chapter 14 – Licenses and Business Regulations, Article III, Coin Operated Amusement Devices, Section 14-38 (a) and (b as follows:

Section 14-38. Fee License.

- (a) The license fee for video gaming terminals pursuant to Illinois Video Gaming Act, shall be Two Hundred Fifty Dollars (\$250.00) per terminal, per year.
The Terminal Operator shall pay the Two Hundred Fifty Dollar (\$250.00) license fee.

(b) The Two Hundred Dollar (\$250.00) license fee shall be non-assignable and non-transferable and shall be personal as to each such device and may not be transferred to any other terminal.

Except as herein amended, all other terms and conditions of Sec. 14-38 shall remain unchanged

All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

This ordinance shall be in full force and effect upon its passage and approval by the Mt. Carmel City Council, as provided by law.

This ordinance shall be printed in pamphlet form.


