

ORDINANCE NO. 2062

AN ORDINANCE RESCINDING ORDINANCE 553 ALCOHOLIC LIQUOR IN THE COMMUNITY ROOM

WHEREAS, the City Council of the City of Mt. Carmel, Wabash County, Illinois is no longer the owner of the third floor of the building formerly known as the Elks building, 219 N Market Street; and

WHEREAS, Ordinance 553 authorized sale and delivery of alcoholic liquor in the city owned community room.

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MT. CARMEL, WABASH COUNTY, ILLINOIS, Ordinance 553, is hereby rescinded:

All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

This ordinance shall be in full force and effect upon its passage and approval by the Mt. Carmel City Council, as provided by law.
