

## **ORDINANCE NO. 2060**

AN ORDINANCE AMENDING CHAPTER 2 ADMINISTRATION, ARTICLE VI BOARDS AND COMMISSIONS, DIVISION 4 PARK BOARD

**NOW THEREFORE BE IT ORDAINED** BY THE CITY COUNCIL OF THE CITY OF MT. CARMEL, WABASH COUNTY, ILLINOIS, Chapter 2 – Administration, Article VI – Boards and Commissions, Division 4, Section 2-251 Created; composition; status of members; terms; meeting dates, is hereby amended to state **AS FOLLOWS:** 

There is hereby created a parks and recreation board for the city which shall consist of five members to be appointed by the Mayor, with the advice and consent of the City Council. The commissioner of Parks and Recreation shall be a member of said board and shall control its actions. The remaining members shall act only in an advisory capacity to the commissioner of parks and recreation. Such appointed members shall serve a three-year term.

The board shall meet the third Monday of the following months: March, June, September, and December of each year. The meetings shall be held in the Council Chambers of The City of Mt Carmel, Wabash County, Illinois at 6:00 PM

All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

This ordinance shall be in full force and effect upon its passage and approval by the Mt. Carmel City Council, as provided by law.

This ordinance shall be printed in pamphlet form.
