## **ORDINANCE NO. 2056**

# AN ORDINANCE APPROVING SUB-DIVIDING A PARCEL AND A VARIANCE FOR SETBACK DEVIATION IN AN R-5 RESIDENTIAL DISTRICT IN THE CITY OF MT. CARMEL, WABASH COUNTY, ILLINOIS

WHEREAS, Zanetis Oil Company LLC, proposes to sub-divide a parcel for transferring ownership within a R-5 Residential District, such subdivision requiring approval of a setback deviation; and

WHEREAS, proper notice was given to all interested parties of such proposed subdivision and variance; and

**WHEREAS**, the Zoning Board of the City of Mt. Carmel, Wabash County, Illinois has by its voting members unanimously approved Sub-division type B 081020211SDB and Variance 081020211V for a deviation in rear setback measurements from 40 feet to 9 feet in said R-5 Residential District.

# NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MT. CARMEL, WABASH OUNTY, ILLINOIS,

That a subdivision of a parcel and variance for a deviation from the setback limits hereby granted to Zanetis Oil Company LLC., such action to take place in an R-5 Residential District. The variance for setback measurements is approved from nine (40) feet to nine (9) feet on the West side of the proposed subdivision for Lot 2.

The description of the real estate covered hereby is as follows:
