ORDINANCE NO. 2055

AN ORDINANCE APPROVING A VARIANCE FOR SETBACK DEVIATION IN AN R-2 RESIDENTIAL DISTRICT IN THE CITY OF MT. CARMEL, WABASH COUNTY, ILLINOIS

WHEREAS, Christopher and Katie Slane, proposes to construct a garage within a R-2 Residential District, such construction requiring approval of a setback deviation; and

WHEREAS, proper notice was given to all interested parties of such proposed variance; and

WHEREAS, the Zoning Board of the City of Mt. Carmel, Wabash County, Illinois has by its voting members unanimously approved Variance 073020211V for a deviation in side setback measurements from 9 feet to 1 foot in said R-2 Residential District.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MT. CARMEL, WABASH OUNTY, ILLINOIS,

That a variance for a deviation from the setback limits hereby granted to Christopher and Katie Slane, such action to take place in an R-2 Residential District. The variance for setback measurements is approved from nine (9) feet to one (1) foot on the north side of the proposed construction site.

The description of the real estate covered hereby is as follows:

SW Corner of Sublot 3 of Subdivision of Lot 2 of SE ¼ of Section 17, Township 1 South, Range 12 W of Second Principal Meridian, thence East 183.4 feet to a point on the west right-of-way line of Route One, thence north 15 degree 27' west a distance of 232 feet to a point thence south 74 degree 33' a distance of 177 feet to a point thence south 15 degree 27' East a distance of 183.8' to the point of beginning.
